

Regatta Arts, LLC invites all nonprofit businesses to participate in the 3rd annual Hand-Car Regatta. The event will take place on Sunday, September 26, 2010 from 11 am to 6 pm in Historic Railroad Square just west of downtown Santa Rosa. For more information on the event, please visit www.handcarregatta.com.

Activities before, during and after the Hand-Car Regatta include an outdoor faire and picnic offering a wide variety of festival foods and beverages, a large area of arts and crafts exhibitors and a special area with hands-on activities to entertain all ages.

All art and community organizations are encouraged to apply early as there are a limited number of nonprofit spaces available:

1. Accepted nonprofit organizations may only distribute promotional materials. The selling of any items, including food, must be approved by the committee. Hands-on and interactive activities are encouraged.
2. If accepted, we will need to have a copy of your insurance on file two weeks prior to the event date that names Regatta Arts, LLC, the City of Santa Rosa and SMART as additional insured.
3. We will need to have a copy of the Federal Tax ID letter that you should have received from the IRS, which confirms your current nonprofit status and includes the organization's tax ID number on it.
4. We provide a 10ft x 10ft space only. Everything else you need for your set up: tents, tables, chairs, umbrellas or signage needs to be provided by your organization.

You are responsible for providing a WHITE, Ez-Up style tent. This is the only tent approved for use at The Regatta.

We can provide you with a tent for an additional \$110.00.

5. We will email you a status letter within a month of us receiving your completed application. You will receive a participant packet that includes everything you need to set up at the event by August 1st, 2010.
6. The fee for applying to the event is \$75 for Santa Rosa based nonprofit groups and \$100 for out of town nonprofit groups.

Regatta Arts, LLC reserves the right to refuse the participation of any entrant it deems offensive, inappropriate, or contrary to the spirit of the event or the City of Santa Rosa.
